This warranty is limited to the original material purchaser.

Due to the variety of uses and applications for Fiberglass Technology Industries, Inc. products, it is the responsibility of the user to determine the suitability and provide proper installation of Fiberglass Technology Industries, Inc. products for their particular application.

Fiberglass Technology Industries, Inc. shall not, under any circumstances, be liable for any incidental, consequential or special damage resulting from the use, service or failure of any panel. Fiberglass Technology Industries, Inc. assumes no responsibility for damage due to misuse, negligence, mishandling, accident, improper installation, mechanical abuse, fire, chemical attack or other casualties excluded from this warranty.
